

TERMS OF RESIDENCE

1. The guest, by signing this registration form, warrants that he is duly authorised to sign and bind all persons represented by him or for whom he is responsible ("his party") to these terms of residence and, failing such authority, agrees to be liable for all amounts arising from the residence of himself and his party at the Residence.
2. The guest and each of his party agrees to pay not later than the time of arrival the deposit as determined by the Manager for the period of residence, incurred by the guest and his party during his/their stay at the Residence.
3. The guest agrees that after his departure, any goods left behind by him and/or his party and the goods shall be deemed to have been forfeited to the Residence.
4.
